Criteria for shareholders to propose the Director Nominee

The Company has set the criteria for minority shareholders nominate candidates to be nominated for the position of directors by nominating them through the Company Secretary in advance of the Shareholders' Meeting, together with information on qualification and consent of the nominated shareholders.

The qualifications of the shareholders to nominate persons to be considered for the position of the aforementioned directors. It requires one or more shareholders to hold at least 5% of the total number of voting rights of the Company, to hold shares continuously from the date of holding until the date of the proposed agenda for such meeting a period of not less than 12 months, such shareholders shall have the right to nominate candidates to be elected to the position of Director.
